## Board of Directors Meeting Minutes

Sunday, November 15, 2015, Jeff Yingling's Residence

Present: Jeff Yingling (President), Christie Bach (Secretary), Roger Williams (Director of Coaching), Phil Biesecker (Tournament Director), Erin Aumen (Fundraising), Jeremy Forrer (Vice President), Anne Cherry (member at large), and Marc Mclean (member at large).

1. Meeting called to order at 7:04 p.m.
2. Lawsuit Status- Depositions are in the process of being completed by the attorneys.
3. October Meeting Minutes were presented by Christie Bach. Roger Williams made motion to approve. Second by Jeremy Forrer. Approved by all.
4. Treasurer's Report- will be emailed to the board members by Patty Wivell.
5. CPYSL Report- Roger Williams and Christie Bach attended the CPYSL November Board Meeting on Nov. 11, 2015. The Chief Executive Officer of EPYSA explained the changes coming to U.S. Youth Soccer next Fall. There will be changes in the field sizes and goal sizes, as well as number of players. Teams will still be able to play up, but player development should be the priority, not team development. The team roster sizes will be determined in January. There will also be no heading in U10 or younger. Game cards have been collected by Christie and will be mailed to CPYSL by the Nov.30 deadline. GYSC did not have any fines or fees issued this season. Preliminary team counts are due January 4th. Final team counts will be due February 1<sup>st</sup>. February 10 will be the CPYSL Competition Committee Meeting. CPYSL is dropping the yearly membership fee of \$100 per club. Team fees will be decreased from \$150 to \$125. The U13 teams will have scheduled games on Saturday in the Spring instead of Sundays. GYSC will reschedule the Referee Course at HAAC in Gettysburg since we did not have enough registrants for the November session.
6. Registrar Report- CPYSL player fees from the fall need to be paid in full. There are 2 player add fees that will be to mailed to CPYSL.
7. Fundraising Report- Jeff presented the possible dates for a Futsal Tournament to be held at Gettysburg HS, Gettysburg MS, and Lincoln Elementary School. We will look at the possibility of adding All-Star Sports Complex, and Gettysburg College. The date that we would be able to secure the majority of the facilities would be March 26<sup>th</sup>. Due to Easter falling on March 27<sup>th</sup>, we would limit the Futsal Tournament to one day of game play instead of two.

8. Club/Team Reports- Roger Williams provided final team records for the Fall 2015 season. We will need to look at our team numbers for the spring season since we are losing a few players due to the baseball season.

9. Training and Development Update- Roger, Jeff, Christie, and Jeremy will meet to discuss tryouts that will be held in the spring for next year and age grouping.

10. New Business

a. Fields at GHS have been closed for the season and are being treated.


b. Winter Training- Mo will be providing winter training for any interested teams and players. Due to lack of numbers, we will most likely combine training.

c. Trailer Storage- We will be renting a storage unit for the upcoming winter. The cost for the year that we were offered is: TRAILER, Outside parking \$240.00 and for 2 - 5x10 Units side by side \$300.00= \$540.00. In addition, the trailer that we currently have at GHS will be repaired of any leaks. All items will be moved to the storage facility within the next few days.

d. Patches- GYSC patches arrived and were handed to teams participating in November tournaments.


11. Meeting adjourned at 9:46 p.m. until January 10, 2016 at 7pm.
